McDonald's M-League 1: 2018 - Rules

1. Teams applying to play in the "McDonald's M-League 1" will pay an application fee as outlined below:

ML - 1: \$1,500.00 payable in 2 instalments:

 1^{st} payment due at team confirmation in January 2018, and the 2^{nd} at commencement of round 1.

This fee covers the competition entry fee, and 10 tickets to the gala dinner. Each club will receive a \$500.00 team incentive payment at the end of the season from the MFA.

- 2. The McDonald's M League 1 competition shall consist of either an 8 team, or 10 team (maximum) competition.
- 3. ML1 <u>and</u> ML2 will begin transition to a squad format from 2018, with teams who fail to nominate a squad in both ML1 and ML2 to be 'paired' with a similar team in the corresponding competition for the purposes of the draw.
- 4. Nominations for "McDonalds M League 1" will consist of one team per application, and will be strictly limited to one team per club however the MFA Board *may consider, by exception,* the addition of a second team in this competition in 2018 if:
 - a) There is a spot available within the maximum 10 team competition structure
 - b) The nominating Club will be required to have two teams in the McDonald's M League 2 competition
 - c) The addition of a 2nd team is not to the detriment of another Club wanting to join the competition
 - d) If second team nomination is approved, the nominating Club will need to pay *two* application fees
- 5. McDonalds M League 1 : Team and Squad Member Numbers and Borrowing Rules:
 - a) Each team may nominate a team size of 16 players, but can borrow any player from within their club without penalty.
 - b) All ML squads and teams will be able to borrow players from lower divisions within their own club on an UNLIMITED basis, with the only exception being that, should a club submit two (2) ML1/2 squads, those squads will be treated as separate entities and no borrowing will be allowed between those squads. For example; A Narellan Red ML1/2 could not borrow players from a Narellan Blue ML1/2 squad and vice versa, but both squads may still borrow players from lower divisions per the new unlimited rule.
 - c) Any squad who nominates for ML1 or ML2 will be allowed to register up to 32 players to be declared as part of their squad.
 - d) All clubs with a squad will still be required to submit an ML1 side with up to 16 players and an ML2 side with up to 16 players for the purpose of determining eligibility for Finals & Champion of Champions.
 - e) All players registered as part of an ML1/2 squad will have unlimited movement within the squad, allowing coaches to select their best available team for ML1 each week.
 - f) Players borrowed from lower All Age divisions and down to under 17's must be aged 16 as at January 1 in the calendar year.

- 6. Clubs can request a regrade for any "McDonald's M League 1" squad member to a lower league prior to 30 June. Any regraded players cannot however, be borrowed again for "McDonald's M League 1" games for the remainder of the season unless that player is a listed Goalkeeper.
- 7. To **nominate a team in** the **"McDonald's M League 1"** competition, please complete the nomination form as annexed to this "Rules" document and return to the MFA Office **no later than 15 December 2017**
- 8. 5 match balls will be provided by the MFA to each "McDonald's M League 1 team"
- 9. The competition will be played as follows:
 - (a) Games shall be played on a home and away basis as allocated by the Fixtures Committee, subject to availability of grounds and referees
 - (b) A minimum of two rounds as determined by the MFA. The team leading the competition on points at the end of the final round will be declared the Premiers.
 - (b) Where teams finish equal on points the goal difference will decide the winner.
 - (c) Should teams still be level in all other aspects they shall play off to determine the Premiership
 - (d) Extra time will be played in the finals series. If the score is equal at full time, 15 minutes each way will be played. If still equal, at the completion of extra time, a penalty shootout will determine the winner.
 - (e) The winner of the "McDonald's M League" (ML 1) Premiership, as per 6 (a) above shall be the Association's nominee in the appropriate Football NSW "Champion of Champions" competition
- 10. Players registered in an ML1/2 squad will automatically be eligible for the ML1 finals series.
- 11. Playing shirts must be numbered and only registered colours of the club may be worn by all "McDonald's M League 1" teams as approved by the MFA. All playing shirts must have the club logo on the left chest, the MFA Association on the right chest and the McDonalds logo on the left sleeve.
- 12. Player Registration Cards are to be contained within a card holder and MFA lanyard worn by players (and Coach and Manager) prior to the start of the game for inspection by the opposition Coach/Manager.
- 13. Selected "McDonald's M League 1" games may be played on the Association's ground at Lynwood Park.
- 14. Clubs with appropriate lighting may apply to play Saturday night matches. The opposing club must agree to the fixture change, night games will not be automatically granted.
- 15. **Forfeits:** Forfeit fines will increase to \$500 in the first instance, and \$1000 in the second instance for all ML and WML competitions from 2018. Any team that forfeits a third time will be withdrawn from the competition and an additional fine or sanction may be imposed
- 16. Game Change Requests: The team requesting the change will complete an electronic form highlighting the request and preferred dates/times to reschedule the fixture. The opposing team will have an opportunity to review and accept the request, or to respond with alternative dates/times. Once the two teams have reached agreement, the form will be forwarded to the Competitions Manager who will facilitate the change. Only in the event that no agreement can be reached may the team requesting the change contact the office for

mediation and resolution of the request by the MFA Competitions Department. Teams must note that even if a change request is accepted, the venue for the fixture cannot be assured and will be assigned on a "best available" basis.

- 17. All other Competition rules and By-Laws of MFA apply to the **"McDonalds's M League"** competitions.

McDonald's M-League 2: 2018 - Rules

1. Teams applying to play in the "McDonald's M-League 2" will pay an application fee as outlined below:

ML - 2: \$750.00 per team payable in 2 instalments:

 1^{st} payment due at team confirmation in January 2018, and the 2^{nd} at commencement of round 1.

This fee covers the competition entry fee, and 10 tickets to the gala dinner.

- 2. The McDonald's M League 2 competition shall consist of either an 8 team, or 10 team (maximum) competition.
- 3. ML1 <u>and</u> ML2 will begin transition to a squad format from 2018, with teams who fail to nominate a squad in both ML1 and ML2 to be 'paired' with a similar team in the corresponding competition for the purposes of the draw.
- 4. Nominations for **"McDonalds M League 2"** will consist of no more than two teams per application, and will be strictly limited to two teams per club however the MFA Board *may consider*, *by exception*, the addition of a third team in this competition in 2018 if:
 - a) There is a spot available within the maximum 10 team competition structure
 - b) The addition of a 3rd team is not to the detriment of another Club wanting to join the competition
 - c) If a third team nomination is approved, the nominating Club will need to pay *three* application fees
- 5. McDonalds M League 2: Team and Squad Member Numbers and Borrowing Rules:
 - a) Each team may nominate a team size of 16 players, but can borrow any player from within their club without penalty.
 - b) All ML squads and teams will be able to borrow players from lower divisions within their own club on an UNLIMITED basis, with the only exception being that, should a club submit two (2) ML1/2 squads, those squads will be treated as separate entities and no borrowing will be allowed between those squads. For example; A Narellan Red ML1/2 could not borrow players from a Narellan Blue ML1/2 squad and vice versa, but both squads may still borrow players from lower divisions per the new unlimited rule.
 - c) Any squad who nominates for ML1 or ML2 will be allowed to register up to 32 players to be declared as part of their squad.
 - d) All clubs with a squad will still be required to submit an ML1 side with up to 16 players and an ML2 side with up to 16 players for the purpose of determining eligibility for Finals & Champion of Champions.
 - e) All players registered as part of an ML1/2 squad will have unlimited movement within the squad, allowing coaches to select their best available team for ML1 each week.
 - f) Players borrowed from lower All Age divisions and down to under 17's must be aged 16 as at January 1 in the calendar year.
- 6. Clubs can request a regrade for any "McDonald's M League 2" squad member to a lower league prior to 30 June. Any regraded players cannot however, be borrowed again for "McDonald's M League 1 or 2" games for the remainder of the season unless that player is a listed Goalkeeper.
