We thank everyone helping us gather email addresses. This allows us to inform you of upcoming events and news in a more timely fashion.



## Stories Behind the Markers

*Member Dave Baumgartner will be spotlighting the history behind the markers erected by the Native Sons and Daughters in each newsletter. This is his first installment.*

Under the shiny new Sprint Arena lies the site of a two story brick and frame building. In early August 1863, this building was to house some of the sweethearts and wives of known bushwhackers, members of Quantrill's Guerrillas.

General Thomas Ewing, the commander of the Union troops in the Kansas City area, decided to arrest and lock up some of the seditiously spirited women, wives and girlfriends. They allegedly furnished food, ammunition, and other contraband to their men in the various bands of Confederate raiders.

Ewing reasoned, hold them hostage, so to speak, and give the Confederate raiders fewer fried chicken dinners and fewer kisses too, thinking to put a damper on some of the raids.

Captured and arrested were Josephine, Mary and Jennie Anderson, sisters of "Bloody Bill," Nattie McCorkle, Mrs. Charity Kerr, sister and sister-in-law of Sgt. John McCorkle, Nannie Harris, Susan Vandiver, the Munday Sisters, Mrs. Armenia Gilvey, a cousin of the Younger Brothers, and Molly Grindstaff.

The youth and beauty of many of these girls ended abruptly on August 14, 1863, along with the lives of four of the women when the prison building collapsed. Among the dead were Josephine Anderson, Christie McCorkle and Susan Vandiver. Southern sympathizers promised revenge as they claimed



the building was undermined by Yankees tired of verbal abuse from the girls, Yankees claimed that the tragedy was caused by rooting hogs that freely ranged beside the walls and under the building from a farm lot behind it. Another story has the girls digging tunnels in the basement of the building in an attempt to escape. The digging supposedly undermined the rickety building and a wind storm blew it down.

Regardless of the story, the result was to fire the feelings of Bill Anderson and Quantrill's men far beyond those of patriotism, states rights, and slavery. Their revenge came in the attack on Lawrence on August 21, 1863, quickly followed by Ewing's issuance of Order Number Eleven. The Order cleared the state line of all but loyal Union residents from the Missouri River to Harrisonville.
