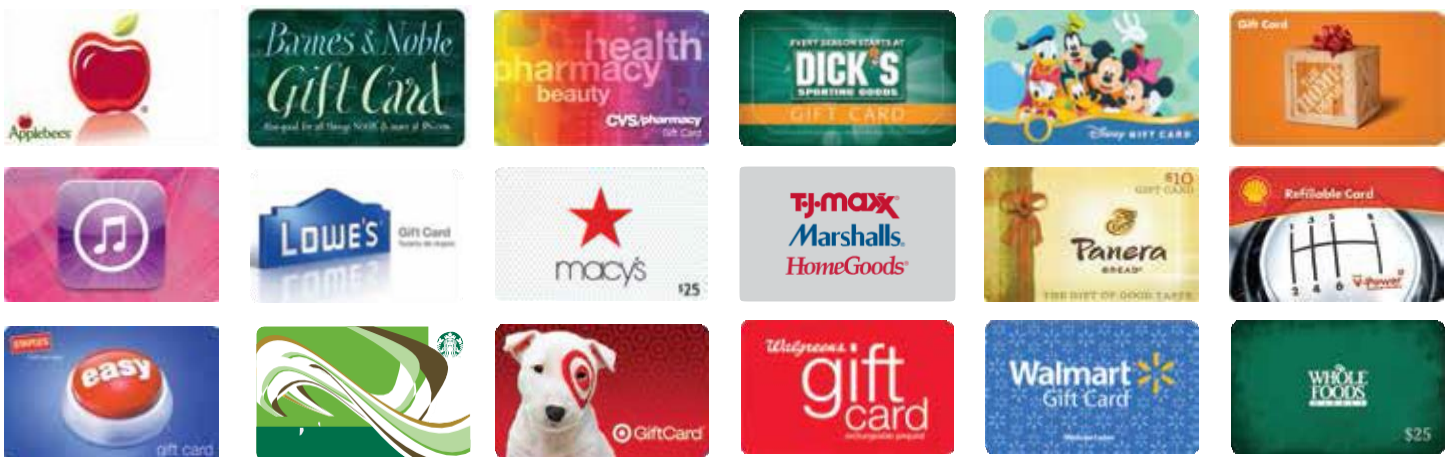

Scrip fundraising is a no-selling program that allows families to raise money for their non-profit organization (NPO) and reduce tuition costs. Scrip is just another way to pay for everyday purchases using gift cards in place of cash, checks, and credit cards.

It is really simple! Help earn funds for your school and towards a student's tuition.

You purchase gift cards (electronic or physical) at www.shopwithscrip.com and www.myscripwallet.com. A rebate is given back to Creekside Christian School (percentages are indicated on the website). The rebate can be split 60% for the school's general fund and 40% towards a student's tuition costs.

When you use scrip gift cards at your favorite retailers, you're fundraising while you shop. Great Lakes Scrip Center offers over 300 of the country's biggest brands, including grocery, department stores, gas stations, restaurants, hotels, home improvement, and more. Just by using scrip to pay for your normal weekly purchases, you can support the school and reduce your tuition. It's time to put your shopping dollars to work!

Reduce your tuition costs!

Beginning April 1, 2016, forty (40) percent of the rebate can be applied to a student's tuition costs. For the student (or family) to get credit for this portion of the rebate, a student or family name must be registered with your account. To ensure you have a child or family registered with your account, please check your account settings and enter a child's name (or family name). If you enter a family name, the rebate credit for tuition will be split equally among the children in that family who are enrolled in Creekside Christian School.

- Rebate credits can only be credited to a child (family) who is indicated on your account settings as of the rebate credit dates below. The child must be enrolled in Creekside Christian School.
- Rebate credits cannot be transferred to another child or family that is not listed in the account settings.
- Rebate credits can only be applied to tuition costs at Creekside Christian School.
- If at the time rebate credits are posted to a child's tuition account and the tuition is paid in full, rebate credits will be given to the school's general fund.
- Rebate credits cannot be given in the form of cash or check.
- Rebate credits will be applied towards future tuition payments.

Rebate credits will be applied to a student's tuition costs on:

- August 1, 2019 (for the period May 1, 2019 – July 31, 2019)
- December 31, 2019 (for the period August 1, 2019 – December 31, 2019)
- April 30, 2020 (for the period January 1, 2020 – April 30, 2020)
