

**TOWN OF SILT
RESOLUTION NO. 28

A RESOLUTION SUPPORTING THE GRANT APPLICATION FOR A STATE OF COLORADO DEPARTMENT OF LOCAL AFFAIRS REVITALIZING MAIN STREETS GRANT UP TO \$50,000 IN ORDER TO OFFSET THE COSTS ASSOCIATED WITH REPAIRING AND REPLACING SIDEWALKS WITHIN THE MAIN STREET DOWNTOWN AREA IN THE TOWN OF SILT, GARFIELD COUNTY, STATE OF COLORADO

WHEREAS, the Town of Silt ("Town") wishes to improve safety, encourage pedestrian mobility, and enhance economic vitality in its Main Street Downtown area; and

WHEREAS, the Town has many Main Street Downtown area sidewalks in need of repair and replacement that could improve safety, encourage pedestrian mobility, and enhance economic vitality; and

WHEREAS, the Town Board of Trustees ("Board") supports staff in its grant application Revitalizing Main Streets Program through the State of Colorado Department of Local Affairs ("DOLA"), up to \$50,000, which does not include the Town's matching ten percent portion of the total cost of project: and

WHEREAS, the Board recognizes that such grant would help to update the Main Street Downtown area, leading to an increase in business activity and retail opportunities; and

WHEREAS, the Board further maintains that such repair and replacement of sidewalks will both encourage pedestrian mobility and reduce the number of citizen injuries resulting from uneven and dilapidated sidewalks, and the Board is dedicated to completing the project within thirty (30) days notification of the grant award; and

WHEREAS, DOLA offers grants in the estimated amount of \$50,000 for such projects that revitalize a municipality's Main Street Downtown area; and

WHEREAS, the Board supports the staff's efforts in applying for this Revitalizing Main Streets Program grant, and agrees to the sequestering of matching funds within its budget.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF TRUSTEES OF THE TOWN OF SILT COLORADO, that:

Section 1. The Board of Trustees of the Town of Silt strongly supports DOLA's Revitalizing Main Streets Program grant application and if awarded, will facilitate the grant through correct and timely bidding procedures and administration.


Section 2. The Board of Trustees of the Town of Silt authorizes the staff time for editing and completion of the grant, as well as the administration of the grant, if awarded.
